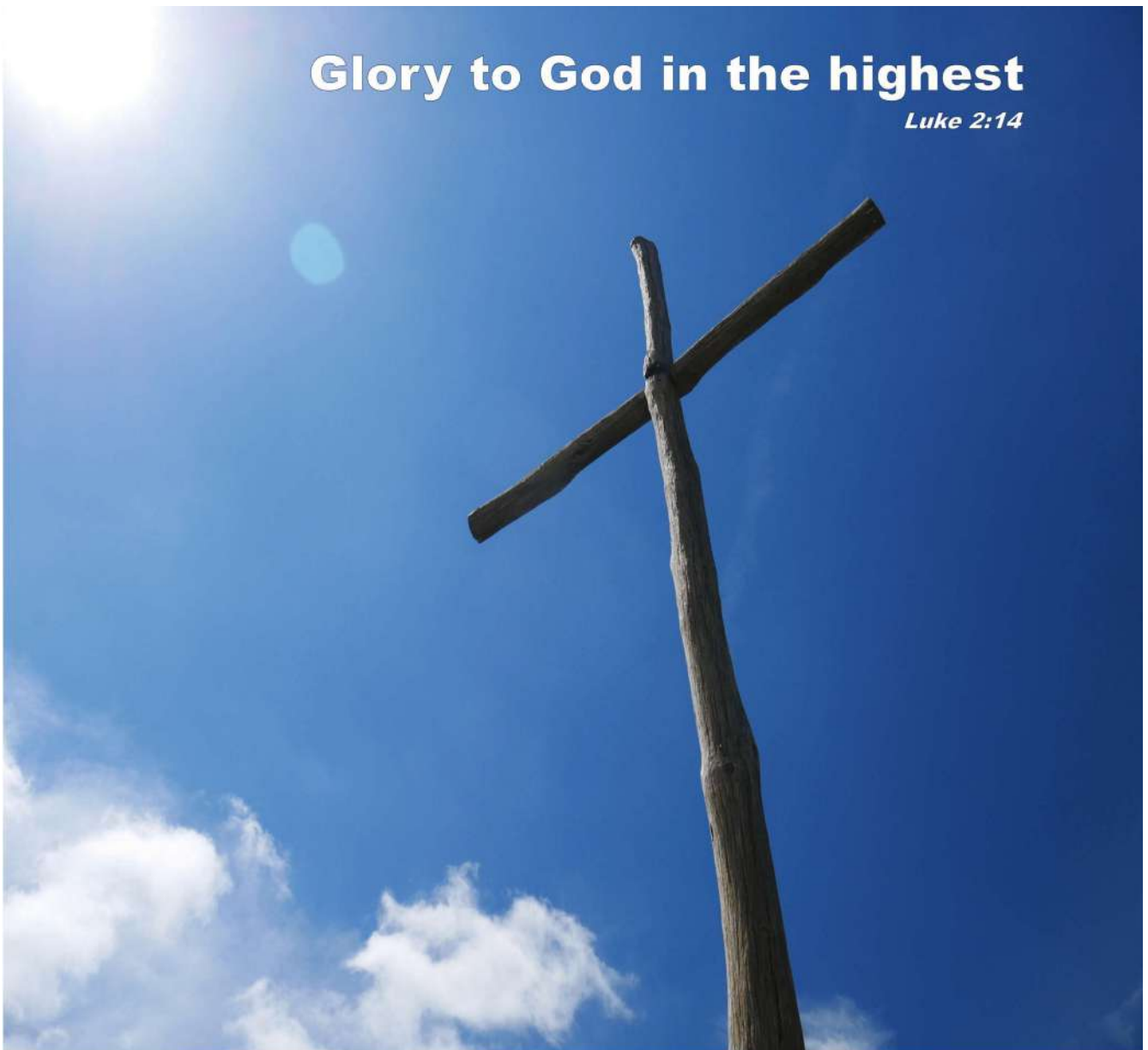

## FROM THE PASTOR'S PEN

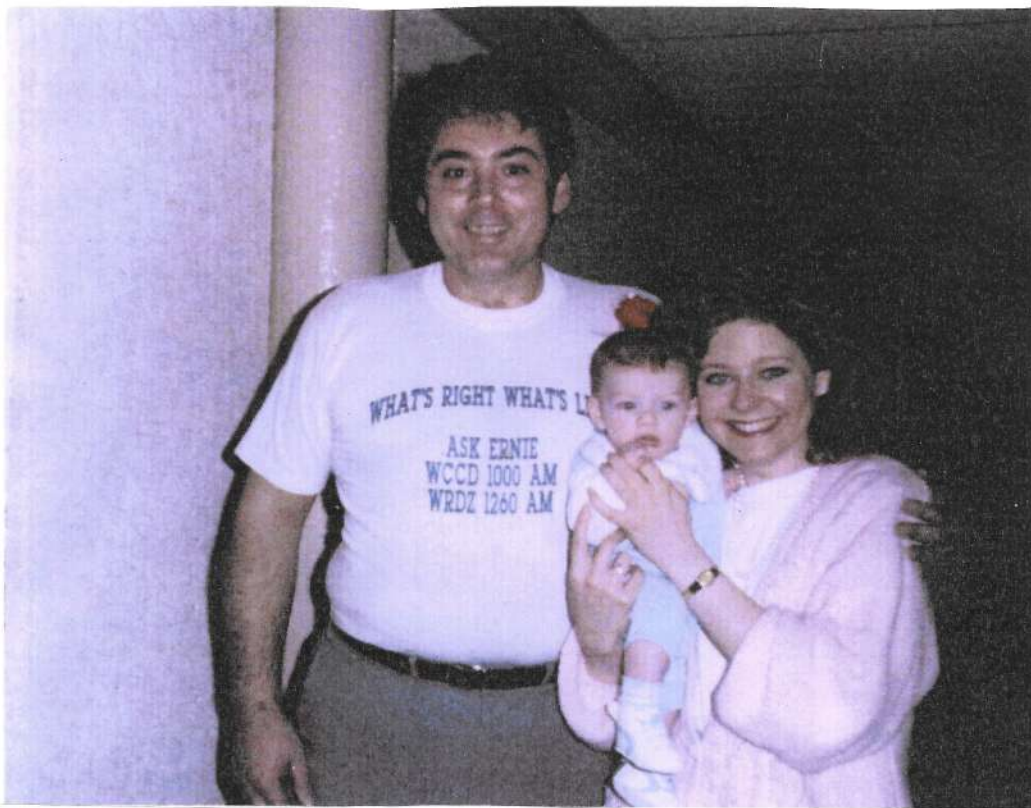

## Is Chief Justice John Roberts the SCOTUS leaker?

**Exclusive: Scott Lively says his initial hunch about incident 'may have been a Word from the Lord'**

It's really no secret that the U.S. Supreme Court has for decades been the global elite's ace in the hole for controlling American policy. SCOTUS is rarely the body where our policies have been conceived and birthed but instead where those policies most threatening to the elites agenda have been aborted. The key to control of that nine-member, ideologically polarized club has been the "swing" voter on the court who serves as the "abortionist of last resort" for killing any policy that could slow or potentially derail the train to global Marxism.

Ironically, I was rudely awakened to this reality in the *Stenberg v. Carhart* (2000) partial-birth child-killing case when swing voter Sandra Day O'Connor was the decider. I was literally in the courtroom to watch the oral argument on that case when, from her own lips, I heard her describe partial-birth child-killing as a "gruesome procedure." I left D.C. that day believing we had won the case because the one person with the power to stop child-murder in the delivery process knew just how evil it really is. But then, shockingly, she sided with the liberals to ensure that gruesome procedure would continue unhindered.

I now believe that O'Connor was not truly the decider in *Carhart* – she was an agent of dark powers behind the court, and her vote to protect the abortion industry was a part of the price she had to pay for her seat at the head table of the elites.

Justice Anthony Kennedy, who had joined O'Connor's *Roe v. Wade*-affirming plurality opinion in *Planned Parenthood v. Casey* in 1992, was the swing voter who notoriously wrote the majority opinion in all four of the SCOTUS opinions establishing "gay" cultural supremacy over Christianity.

Importantly, Chief Justice John Roberts became the key swing voter on several ideologically polarizing cases – until President Trump's appointment of Amy Coney Barrett created a 6-3 conservative-liberal split.

This change in the balance has robbed Roberts of power, a fact that is prominently showcased in the growing scandal over the unprecedented leak of the draft opinion of the *Dobbs v. Jackson* case that will finally overturn *Roe v. Wade* unless the left can intimidate one of the conservatives into changing his or her vote. Roberts is simply impotent to protect *Roe v. Wade* without cheating, and the whole world can see it.

For that reason my immediate gut-reaction guess as to who the leaker might be was Roberts himself. On reconsideration, that seems improbable. But in working through the arguments and counter-arguments in my mind, it struck me that the main reason that possibility is implausible is that Roberts is best-known for his supposed protectiveness of the court's reputation for political neutrality. That priority is supposedly what motivated Roberts to prevent all of the Trump-related election-fraud lawsuits from getting a hearing on the merits.

If Roberts truly is a zealot in the cause of the court's political neutrality, the single best action he could take to prevent a recurrence of this appalling breach of security is to deliberately and openly add his vote to the pro-life side of the case as a form of "sanction" against the anti-life radicals now waging a pressure campaign against the conservatives.

Now, as a practical matter, sanctions are punishments related to the conduct of the *parties* to a case, not to individuals or groups in the larger society. In this case, however, as the votes stand, Roberts' vote would be irrelevant to

## Law bans attempts to 'influence' Supremes, but DOJ silent on near-riots at justices' homes

**'The leak has unleashed leftist rage and illustrated the movement's worst anti-democratic impulses'**

Federal law bans activism, such as picketing, protesting or parading, by someone with the "intent of interfering with, obstructing, or impeding the administration of justice, or with the intent of influencing any judge, juror, witness, or court officer," yet U.S. Attorney General Merrick Garland has gone mum on pro-abortion near-riots at the homes of sitting Supreme Court justices nearing release of their decision on *Roe v. Wade*.

Fox News Digital reports that Joe Biden's Department of Justice failed even to respond to its request for comment on why Garland has refused to address the conflict, and "the reason why protesters have not been arrested."

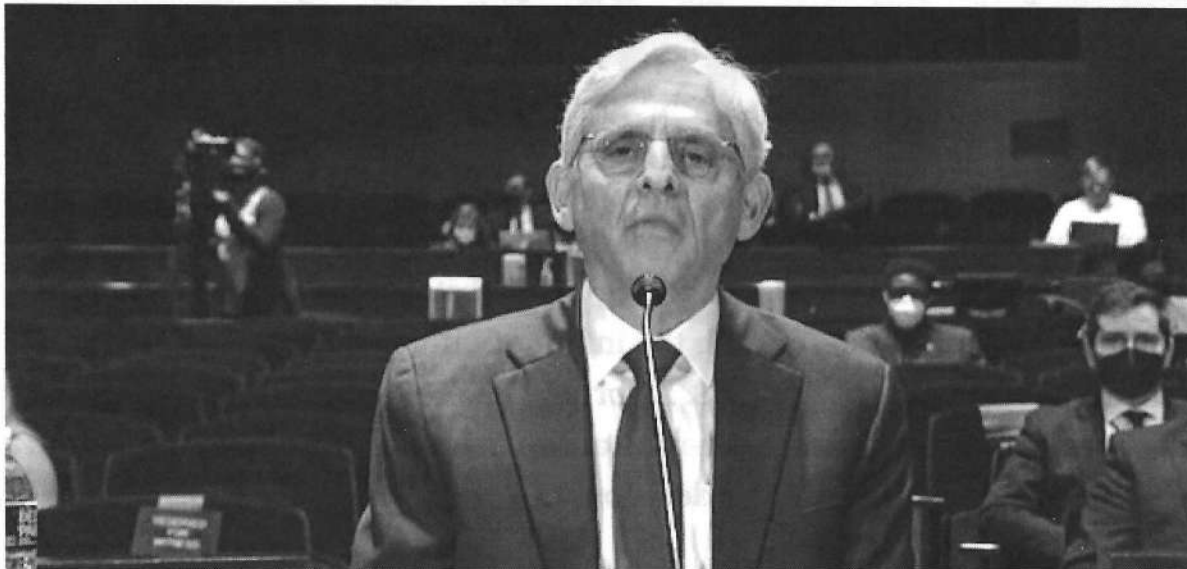


The issue arose over the leak – apparently by someone inside the Supreme Court – of a stolen draft opinion reportedly supported by the court's majority that would, if it becomes final, overturn *Roe v. Wade* and return regulation of abortion across America to the individual states.

Since then, pro-abortion radicals, including those inside the government, have been trying to protect their industry. There have been threats, acts of vandalism, marches, parades and protests – sometimes nearly turning in riots – outside government buildings and the homes of several of the justices, with the obvious intent of getting at least one justice to change positions.

Fox reported, however, that some of those actions are barred by federal law.

"The Department of Justice is remaining silent on continued protests by abortion activists outside conservative Supreme Court justices' homes, despite a federal law that makes it illegal to attempt to 'influence' federal officials and the outcome of a court case," the report said.

# Now Florida to teach students 'evils of communism'

**'Best way to ensure that history does not repeat itself,' says Gov. Ron DeSantis**

Florida Gov. Ron DeSantis signed a bill into law Monday that recognizes a statewide “Victims of Communism Day” requiring Florida schools to teach

students about “the evils of communism.”

The “Victims of Communism Day” bill, or House Bill (HB) 395, establishes November 7 as a holiday “to honor the hundreds of millions of people who have suffered under communist regimes across the world,” which public schools are required to observe, according to a press release.

“Honoring the people that have fallen victim to communist regimes and teaching our students about those atrocities is the best way to ensure that history does not repeat itself,” DeSantis said in a statement. “Through HB 395 and the funding announced today, we are guaranteeing that the history of those who fled communist regimes and their experiences are preserved and not forgotten by our students.”

“While it’s fashionable in some circles to whitewash the history of communism, Florida will stand for truth and remain as a beachhead for freedom,” he added.

Starting with the 2023-2024 school year, high school students taking the state-mandated U.S. government class must receive at least 45 minutes of instruction on the designated “Victims of Communism Day” covering topics “such as Mao Zedong and the Cultural Revolution, Joseph Stalin and the Soviet System, Fidel Castro and the Cuban Revolution, Vladimir Lenin and the Russian Revolution, Pol Pot and the Khmer Rouge, and Nicolás Maduro and the Chavismo movement,” according to the bill.

By April 1, 2023, the State Board of Education must also adopt revised social studies standards for the U.S. government class to incorporate the requirements of the new law.
