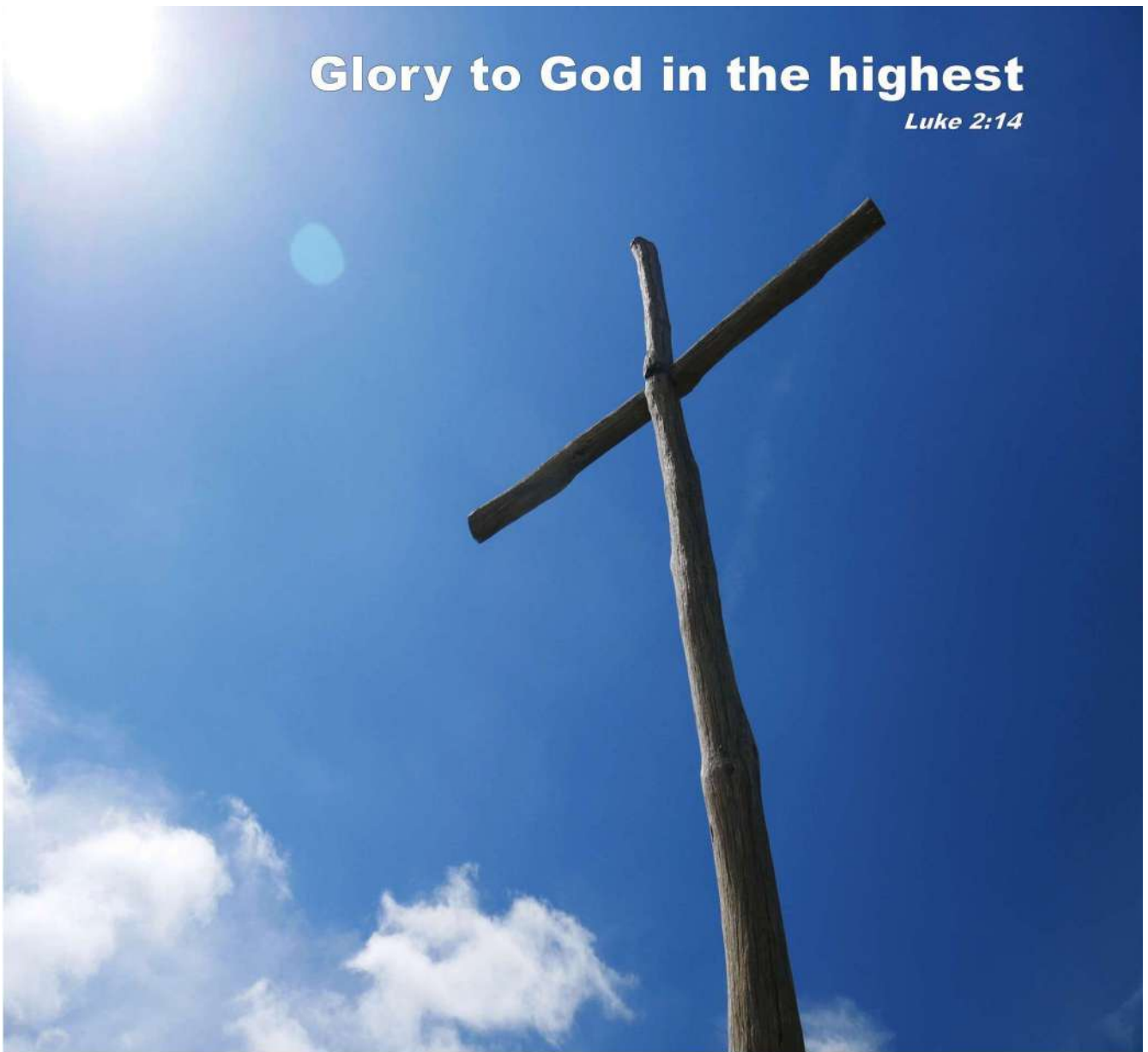

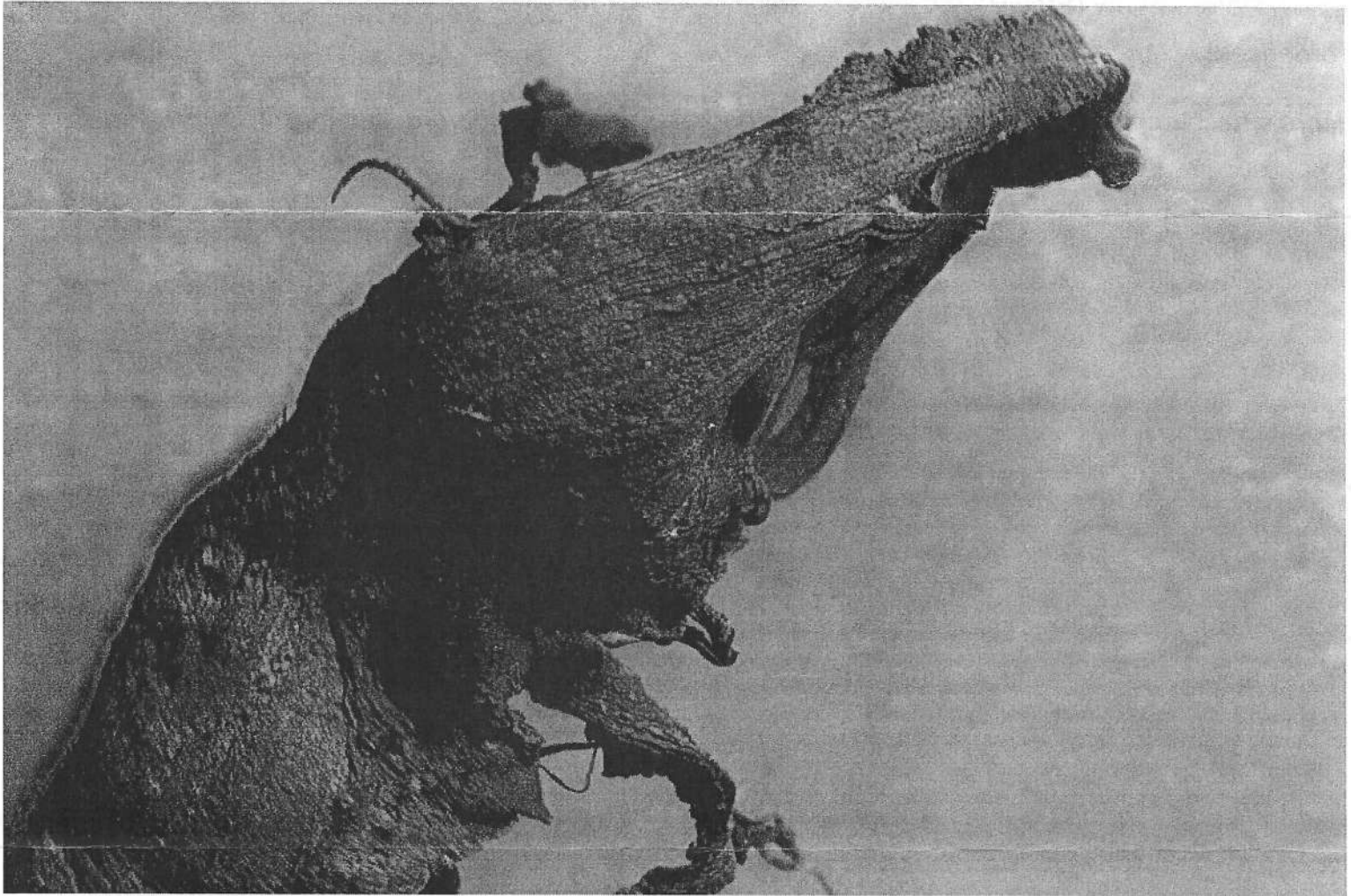

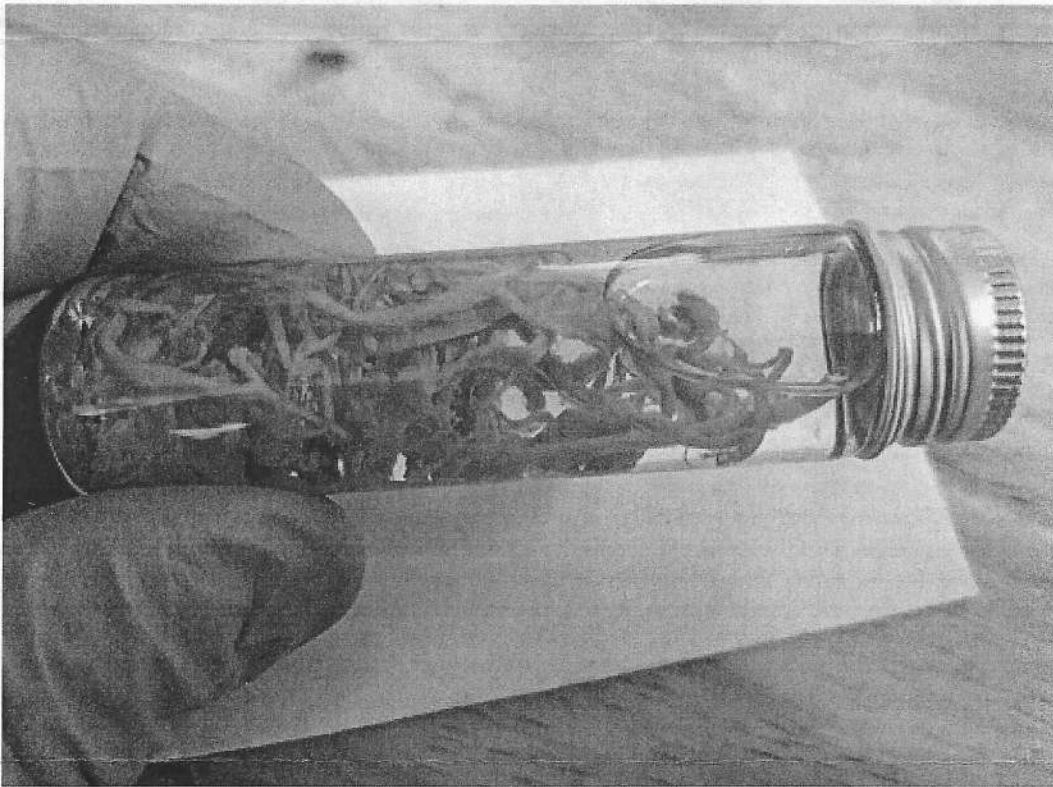
These clots are often referred to as “blood clots” but they are nothing at all like normal clots, and they consist of far more than mere blood cells. Unlike normal clots which are gelatinous, almost jelly-like, these so-called “clots” contain extremely large, complex, **repeating structural elements** (all shown below) that are clearly being constructed in the blood of the victims who died from these clots.



All of these clots were extracted from patients within a few hours of their death. These are not the result of post-mortem blood stasis. These are *structures* found in blood vessels and arteries. They are not congealed blood.

These structures exhibit the following shocking properties:

- They are tough, fibrous and resilient, showing material properties similar to small rubber bands.
- They consist of many strands of small, fibrous strands.
- These fibrous strands (see the very last photo set below) show repeating patterns of scale-like engineering, as if the body has been programmed to build another life form inside the blood vessels.
- There are strange crystalline-like structures found on these clots, exhibiting transparency and resistance to normal gram staining techniques.

# Pro-abortion Jewish organizations agree with Satanic Temple claim that “abortion ritual” represents “religious freedom”

(Natural News) More than 140 Jewish organizations, along with the Satanic Temple of New York City, are now claiming that getting an abortion is a form of “religious freedom” that is constitutionally protected and cannot be overruled by legislators or the courts.

On May 17, an event sponsored by “Jewish Rally for Abortion Justice” and supported by the Anti-Defamation League, publicly affirmed that “abortion access is a Jewish value” and that “banning abortions is a religious freedom issue.”

In early June, a south Florida synagogue filed a lawsuit claiming that the state’s new 15-week abortion ban violates the “religious freedom” of Jewish people. This is the same position held by the Satanic Temple of New York City, which claims that the “abortion ritual” is a form of “religious expression.”

According to Satanists, “birthing people” – meaning women – who belong to the religion should be allowed to freely murder their unborn children whenever they feel like it because this is a form of

worship to their god. The Jewish groups agree.

"How have we not dismantled the government?" the Satanic Temple asked after the Supreme Court's overruling of *Roe v. Wade*, calling the decision "illegitimate" and promising to "defy" it.

In 2015, the Satanic Temple filed a federal lawsuit in Missouri claiming that the state's restrictive abortion laws violate their "free exercise" of Satanism. Five years later, Satanists launched a campaign called "Satanic Abortions Are Protected by Religious Liberty Laws," and have since reiterated their position that Satanism is "the leading beacon of light in the battle for abortion access."



"With *Roe v. Wade* overturned, a religious exemption will be the only available challenge to many restrictions to access," tweeted the Satanic Temple's official Twitter account on June, 24.

## Ending someone else's life does not qualify as religious expression

Frank Pavone, the national director of Priests for Life, stated in a recent interview that since abortion involves the killing of someone else's life, it does not qualify under a religious exemption.

"Killing [of] an innocent human life ... the government can, in fact, restrict [this act], even if someone is going to say, 'My religious freedom requires me, *requires me*, in certain circumstances to abort,'" he is quoted as saying.

Sincerely held religious beliefs that do not involve murder still qualify, but this is something entirely different.

"Nevertheless, the government can restrict someone's religious freedom precisely out of an interest to protect others," he added.

Pointing to several legal cases involving this issue, Pavone further explained how the government does, in some cases, have a compelling interest to interfere with or halt certain religious activities if they put the lives of others at risk.

"Based on the words in the Gospel that 'they will handle poisonous snakes and not be harmed,' some of these churches had snake handling going on in their services," he explained about how poisonous snake handling in the South had to be addressed by the government.

In the wake of the Supreme Court decision overturning Roe v. Wade, major corporations are adding abortion travel costs to their employee benefits.

The goal is to ensure their employees can seek abortion care if they live in states where the procedure is now or will soon be illegal. About 26 U.S. states are expected to swiftly outlaw abortion following the overturn of the landmark 1973 ruling, according to the Guttmacher Institute, which researches reproductive issues.

A trickle of companies announced abortion travel coverage earlier this year after states including Texas introduced restrictive abortion laws. But more corporations have followed in the wake of the Supreme Court ruling on Friday, with dozens of companies representing millions workers now pledging to cover travel costs in case their employees need abortion care.

# **Chemtrails, Nanoaluminum and Neurodegenerative and Neurodevelopmental Effects**

The Internet is littered with stories of "chemtrails" and geoengineering to combat "global warming" and until recently I took these stories with a grain of salt. One of the main reasons for my skepticism was that I rarely saw what they were describing in the skies. But over the past several years I have noticed a great number of these trails and I have to admit they are not like the contrails I grew up seeing in the skies. They are extensive, quite broad, are laid in a definite pattern and slowly evolve into artificial clouds. Of particular concern is that there are now so many dozens every day are littering the skies.

My major concern is that there is evidence that they are spraying tons of nanosized aluminum compounds. It has been demonstrated in the scientific and medical literature that nanosized particles are infinitely more reactive and induce intense inflammation in a number of tissues. Of special concern is the effect of these nanoparticles on the brain and spinal cord, as a growing list of neurodegenerative diseases, including Alzheimer's dementia, Parkinson's disease and Lou Gehrig's disease (ALS) are strongly related to exposure to environmental aluminum.

Nanoparticles of aluminum are not only infinitely more inflammatory, they also easily penetrate the brain by a number of routes, including the blood and olfactory nerves (the smell nerves in the nose). Studies have shown that these particles pass along the olfactory neural tracts, which connect directly to the area of the brain that is not only most effected by Alzheimer's disease, but also the earliest affected in the course of the disease. It also has the highest level of brain aluminum in Alzheimer's cases.

The intranasal route of exposure makes spraying of massive amounts of nanoaluminum into the skies especially hazardous, as it will be inhaled by people of all ages, including babies and small children for many hours. We know that older people have the greatest reaction to this airborne aluminum. Because of the nanosizing of the aluminum particles being used, home filtering system will not remove the aluminum, thus prolonging exposure, even indoors.

In addition to inhaling nanoaluminum, such spraying will saturate the ground, water and vegetation with high levels of aluminum. Normally, aluminum is poorly absorbed from the GI tract, but nanoaluminum is absorbed in much higher amounts. This absorbed aluminum has been shown to be distributed to a number of organs and tissues including the brain and spinal cord. Inhaling this environmentally suspended nanoaluminum will also produce tremendous inflammatory reaction within the lungs, which will pose a significant hazard to children and adults with asthma and pulmonary diseases.

I pray that the pilots who are spraying this dangerous substance fully understand that they are destroying the life and health of their families as well.

This is also true of our political officials. Once the soil, plants and water sources are heavily contaminated there will be no way to reverse the damage that has been done. Steps need to be taken now to prevent an impending health disaster of enormous proportions if this project is not stopped immediately. Otherwise we will see an explosive increase in neurodegenerative diseases occurring in adults and the elderly in unprecedented rates as well as neurodevelopmental disorders in our children.
