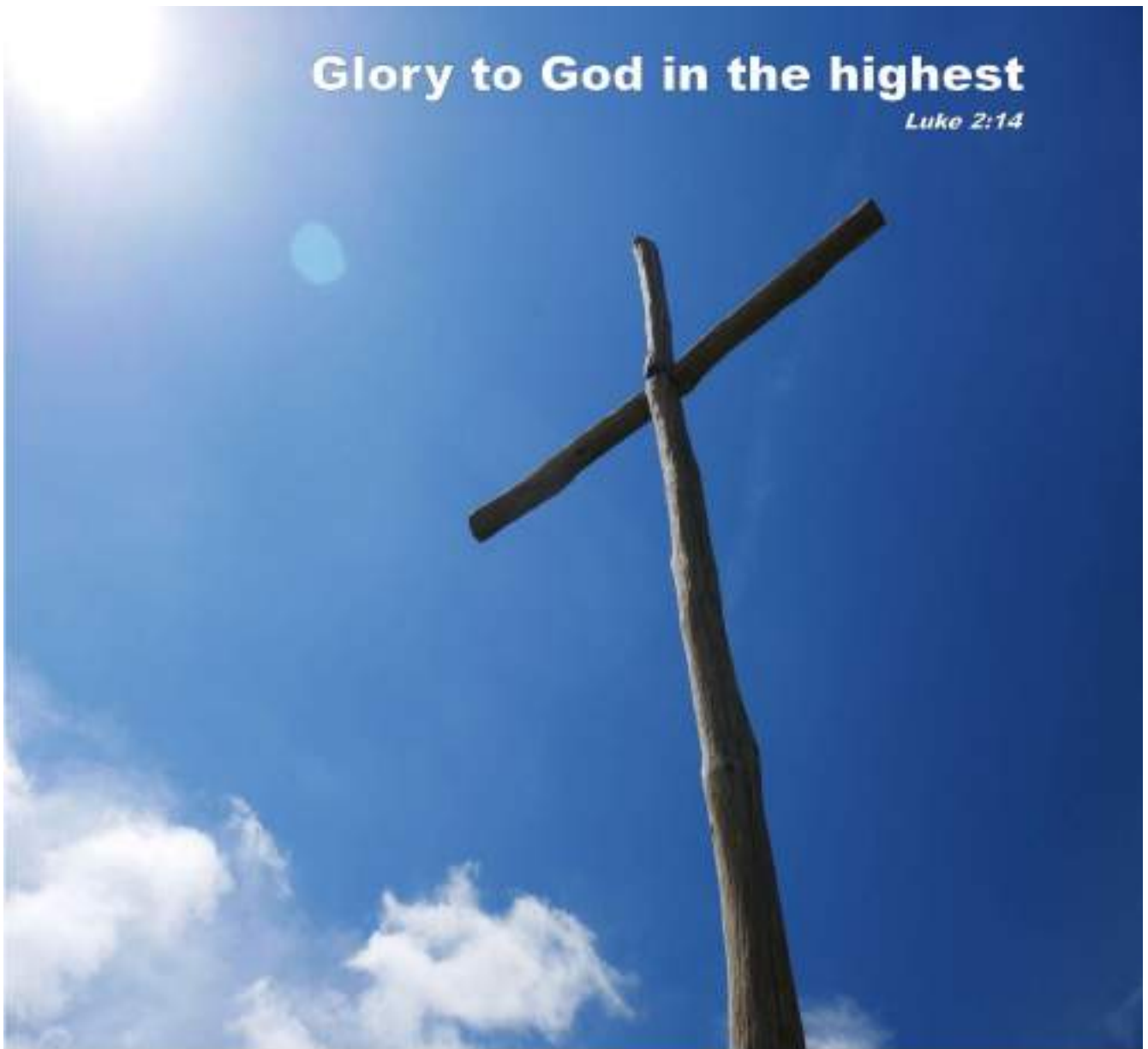

Entering 2023, Concerns About Army Recruiting Loom

Military recruiting has struggled throughout 2022.

The Gateway Pundit reported that earlier in 2022, military leaders announced they would be lowering their recruiting goal for the Army from 476,000 to about 466,000. Despite lowering this goal, the U.S Army is reporting it will miss recruiting goals for the year by 15,000 soldiers.

Recruiting across the branches has likely been hampered by COVID vaccine requirements but also the **increasingly woke military** atmosphere where **trans soldiers are give special privileges while Christian soldiers are persecuted**, bases host **drag shows**, and leaders with a history of **anti-white** statements are hired.

Concerns about Army recruiting goals for 2023 loom.

The Military Times reports:

As the Army rolls along into 2023, everyone from recruiters to senior leaders to Congress are closely monitoring whether the Army will be able

to shore up its recruiting and stem the end strength freefall that the service is currently experiencing.

The service experienced a shortfall of 15,000 recruits in fiscal 2022, which caused it to miss its congressionally-authorized end strength by **nearly 20,000 soldiers**.

And service officials have expressed fear that they won't be able to rebound in fiscal 2023, telling Congress they think they will shrink to between 445,000 and 452,000 troops. Lawmakers responded by **cutting their authorization** to 452,000 in the compromise version of the defense policy bill.

It's not clear how the continuing decline in manning will impact operations, though service officials insist that the Army will be able to meet all of its requirements with fewer troops, indicating that a **potential restructuring of brigade combat teams** could help.

"End strength is supposed to be tied to requirements," said Katherine Kuzminski of the Center for a New American Security think tank. "And so the question becomes: if the end strength is reduced, are the requirements reduced?"

DOJ Employed 'Reverse Spying' In Attempt To Shut Down Investigation Into Russia Collusion Hoax: Devin Nunes

Devin Nunes subpoenaed the DOJ and FBI for documents related to their involvement with the Russia collusion hoax when he was a congressman and chair of the House Intelligence Committee. **In response, the DOJ engaged in “reverse spying” to try and stop the investigation**, Nunes alleged in an interview that aired on Newsmakers by NTD and The Epoch Times on Dec. 21.

“It’s all common knowledge now that the FBI, DOJ, the Democrat National Party, they were all in cahoots together, taking made-up, phony dirt and taking it before a FISA court,” said Nunes, who was chair of the intelligence committee from 2015–2019.

But, at the time, the general public didn’t know about that collusion.

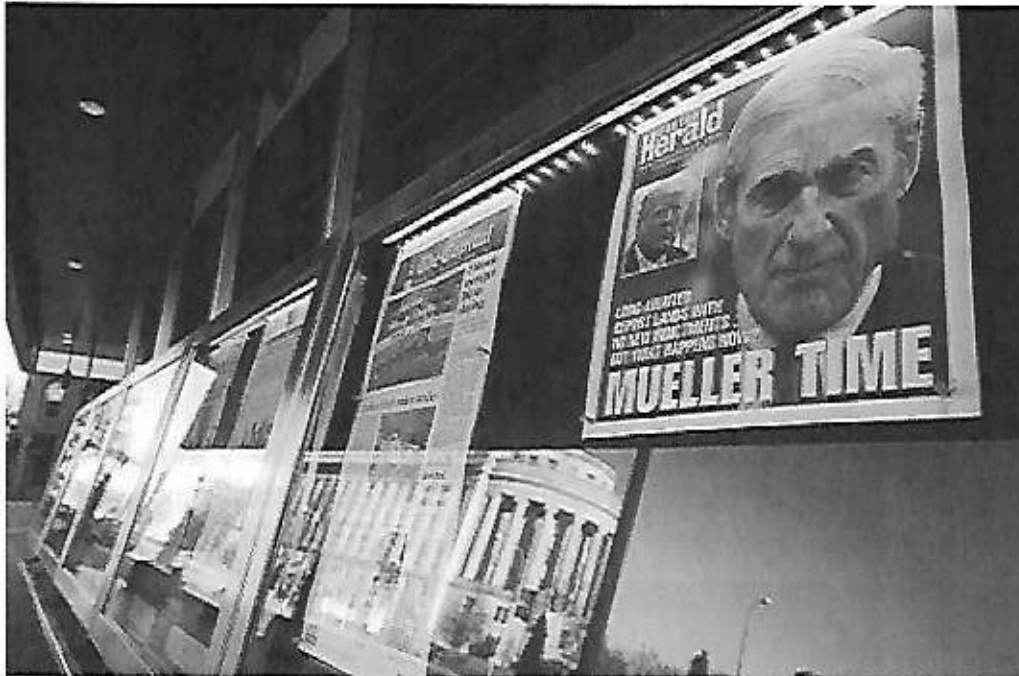
“At that time, nobody knew that publicly. **We knew that. The FBI and the DOJ knew that we knew that.** They knew that they were under investigation by [Nunes’ team]. So, what do they do? ... They target my

lawyers so they can try and figure out what we knew, when we knew it, and what we were going to do with the information.”

Nunes stated that to suppress the investigation, the FBI and the DOJ purposefully tried to find “blackmail” to use against Nunes’ staff.

“It wasn’t like they were in search of some crime. What they were really after was intelligence, and potentially blackmail, to figure out how they could stop the information,” Nunes alleged.

But ultimately, the DOJ’s reverse spying was unsuccessful, Nunes stated, and he was able to openly shed light on the cooperation between the DOJ, the FBI, and the Democrat National Party to bring down then-President Donald Trump.

No Valid Predicate

According to Nunes, if the DOJ was acting in compliance with the law, it should have informed Nunes when it demanded Google turn over personal email and phone data from at least two senior intelligence members of Nunes’ team. Nunes specified that the team members were working on the congressional probe into the Russia hoax.

“Look, it’s a serious issue if I’ve got staff that work for me that are handling the nation’s highest secrets. If I have staff that are somehow doing something wrong, [the DOJ] should have come to me and told me.”

Nunes said that the only way for the DOJ to get around that requirement is to use the National Security Division and “essentially accuse” Nunes and his team of being “agents of Putin.”

“There’s no other way around [informing me]. They have a duty and a responsibility if there are staffers that are involved in some shenanigans or nefarious activity, they should have come to me immediately,” Nunes states.

But, Nunes said, the DOJ never informed him of a potential issue with his staffers. And the reason is the DOJ was acting outside of a "valid predicate" and instead acting on a "lie." Nunes stated unequivocally that there was never evidence to suggest that his staff were Russian agents.

As such, Nunes claimed, there are only two possible reasons for the subpoenas against Nunes' staff.

"The only two logical reasons: They were there to grab intelligence on us as we were conducting our investigation, and two, to look for anything they could possibly do to find blackmail so they could stop this information from coming out and their involvement from coming out."

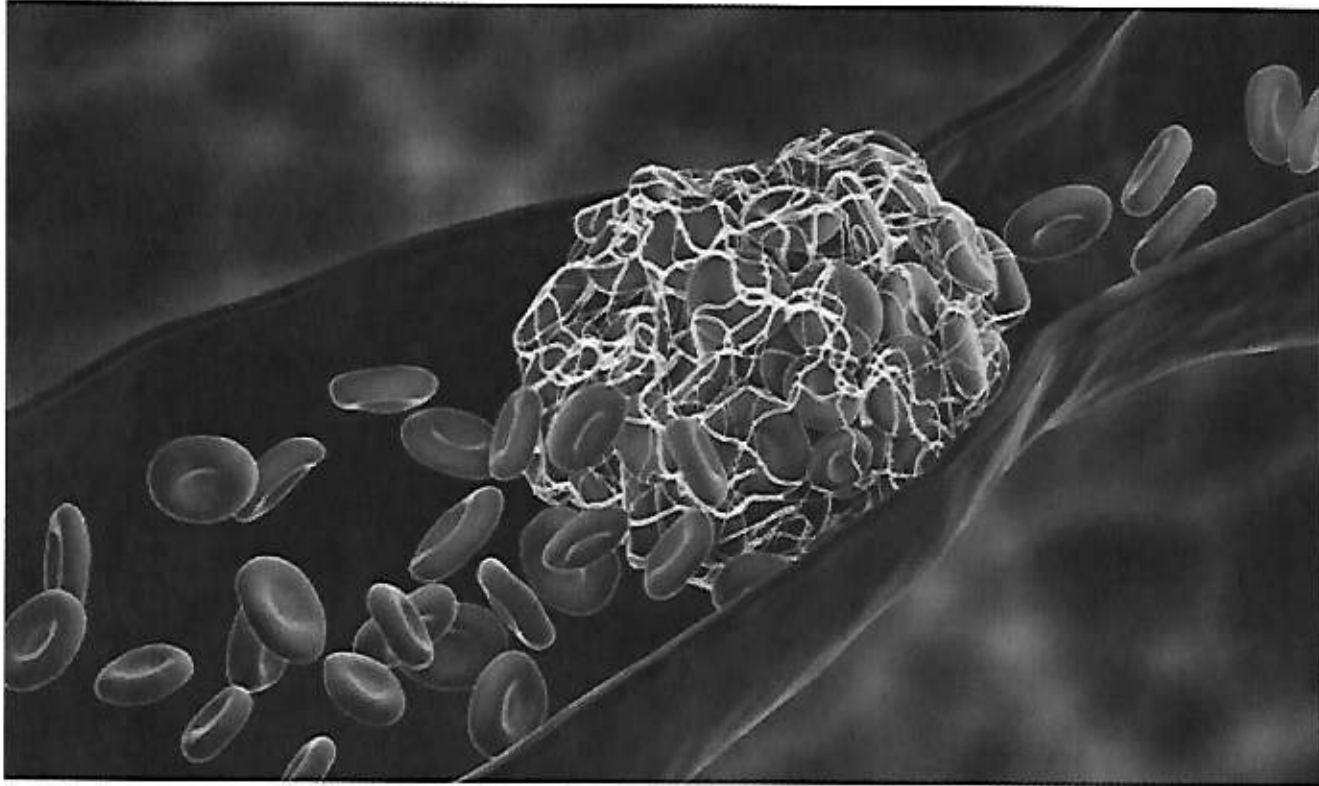

Study shows mRNA COVID vaccine damages heart muscle cells, leading to DEATH

(Natural News) A peer-reviewed study published by a group of leading German pathologists showed that autopsy findings in people who died unexpectedly within 20 days of getting injected with mRNA Wuhan coronavirus (COVID-19) vaccine showed clear indication of myocardiocyte destruction, or damaged heart muscle cells. There are clearly visible lymphocytes that are not supposed to be there.

The analysis, accompanied by specific diagrams, leaves very little doubt that those were cases of vaccine-induced myocarditis. Much of the damage shown is near the surface of the heart. Basically, the spike proteins from the mRNA vaccine get into the heart muscle and cause cardiac arrest. This is being described as a DIRECT LINK, where the doctors are not making a leap and hypothesizing about indirect causes.

Spike protein prions from the Pfizer and Moderna mRNA vaccines get into the heart and lead to cardiac arrest

In laymen's terms, a lymphocyte is a type of white blood cell in the immune system of most vertebrates, and can include natural killer cells, T cells, and B cells. They are the main type of cell found in lymph,

making up roughly between 20 percent and 40 percent of circulating white blood cells. A high number of white blood cells and their subtypes are associated with coronary heart disease, peripheral arterial disease and stroke.

German researchers concluded from the study, which was published in *Clinical Research in Cardiology*, the official journal of the German Cardiac Society, that 30 to 40 percent of the deaths were due to the COVID vaccines.



The most notable and alarming revelation from the study is that the selection of autopsies were from people who died within a month of COVID vaccination (and several within a week), and the inflammation of the heart tissue and muscle were NOT due to pre-existing heart disease. In total, 35 autopsies were studied at the *University of Heidelberg*. In other words, the heart problems were brand new and developed very quickly post vaccination.

As the researchers noted: "All cases lacked significant coronary heart disease, acute or chronic manifestations of ischemic heart disease, manifestations of cardiomyopathy or other signs of a pre-existing, clinically relevant heart disease." This further pinned and directly linked the cause of death to the spike-protein-creating injections.

Spike proteins are infectious agents that damage heart tissue and can lead to death within 30 days of "vaccination"

People are dying suddenly after COVID vaccination, and the study reviewed in this article does not even address people who get clot shot booster shots. Apparently, just one or two spike protein shots is enough to trigger cardiovascular death within a few weeks as the spike proteins get into the heart and trigger a fatal autoimmune attack on the heart. The immune system assumes the foreign particles are enemies invading the heart, and the immune system attacks them. The result is fatal to the vaccinated victim.
