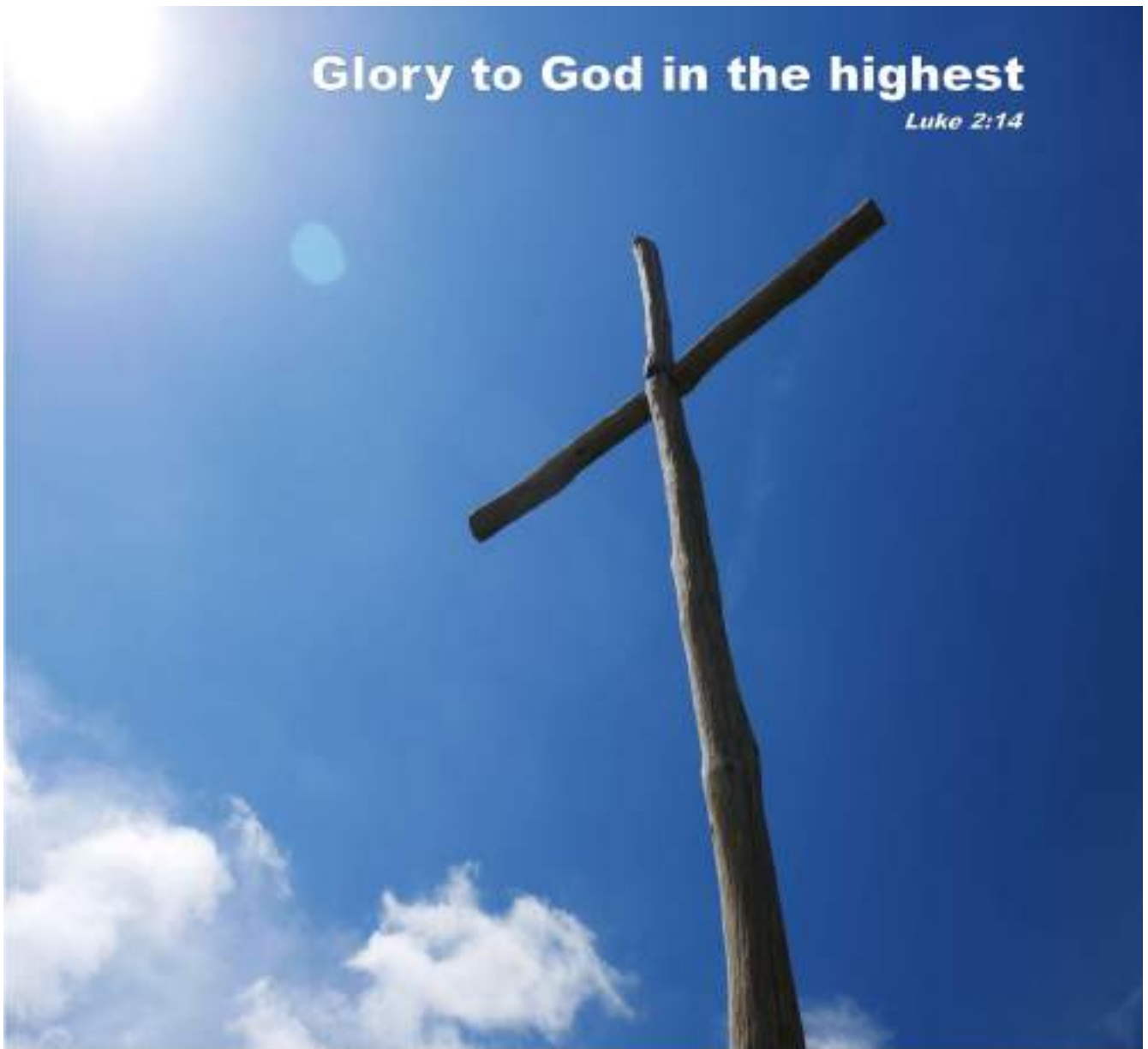

On October 31, the Crime Prevention Research Center (CPRC) released a list of cases across the United States, outlining violence against both pro-life and pro-abortion groups. Despite mainstream media coverage focused on the abortion advocates, the information gathered proves that pro-lifers experienced threats and violence in far greater numbers.

“We identified 135 attacks on pro-life entities and people between when the [Supreme Court opinion] leak occurred and September 24th, 2022,” the report states. “By contrast, only six cases involve pro-choice [sic] people attacked.”

The study consisted of different sources including news searches and an attempt to gather information on “additional cases” from pro-abortion organizations. These groups “refused to respond” to the requests “despite efforts over three weeks.”

“The bottom line is that after the Dobbs decision was leaked, there was over 22 times more violence directed against pro-life groups than pro-choice organizations,” the report continues.

“However, if the media is less likely to cover violence [against] pro-life organizations, the 22 times estimate will underestimate the relative violence against these groups.”

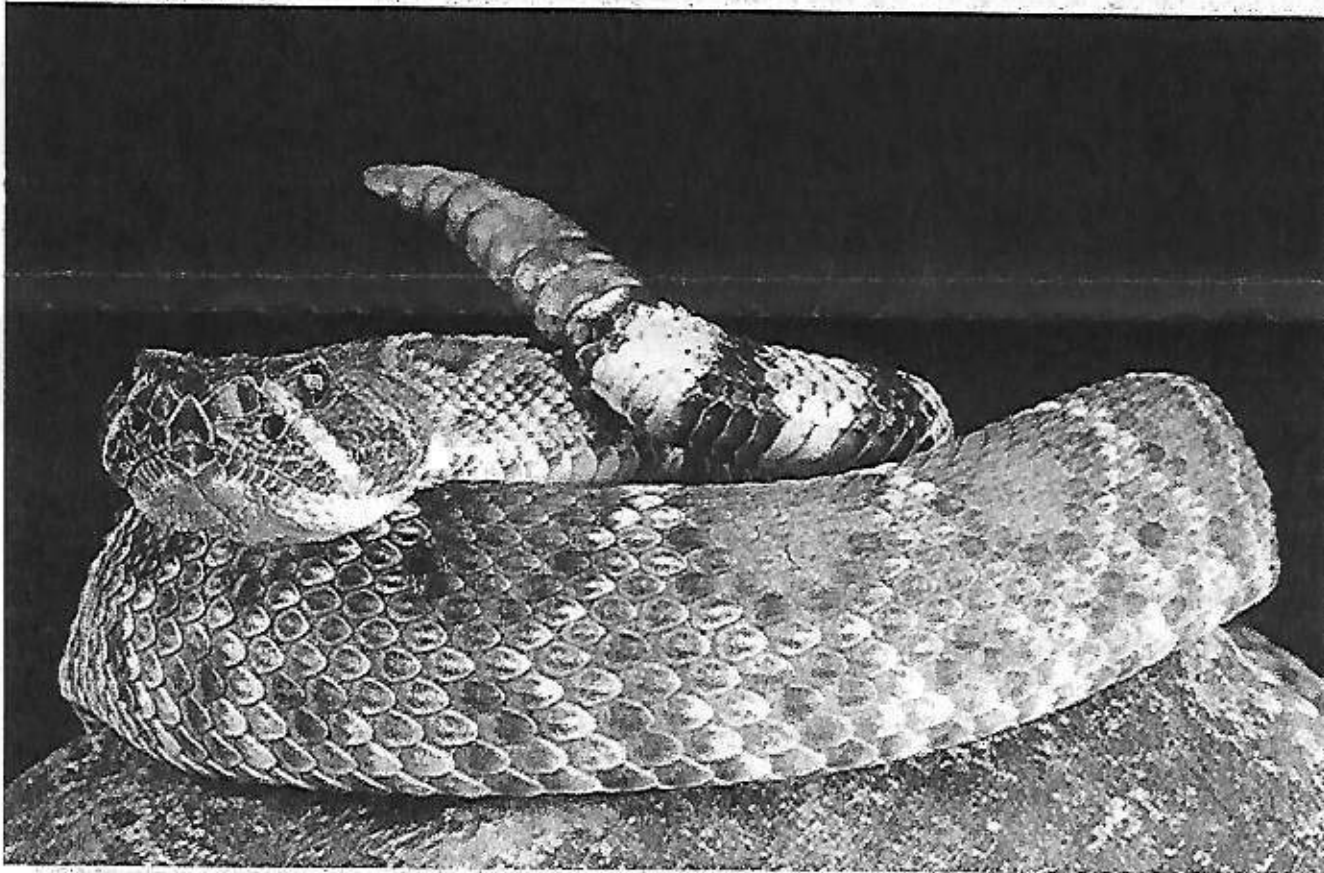
According to the study, the U.S. Department of Justice (DOJ) maintains a list of “recent cases on violence against reproductive healthcare providers.” However, “it doesn’t collect similar data for cases against pro-life centers.” The study sought to compile “extensive news searches and contacted various organizations on both sides of the debate.”

Dr. Bryan Ardis: Engineered COVID virus contains DOZENS of synthetic animal venoms

(Natural News) In a recent interview with Dr. Jane Ruby on the "Dr. Jane Ruby Show," Dr. Bryan Ardis said his initial conclusion regarding the Wuhan coronavirus (COVID-19) – that it was made up of two synthesized snake venoms mixed with other genetic material – is wrong. He now believes that the engineered virus is made up of possibly dozens of different synthetic venoms.

Ardis based his conclusions from multiple studies in early 2020. At the time, most mainstream news outlets noted that snakes could be the original source of the coronavirus. This theory was later scrapped for what media outlets claimed was the more plausible source – bats. (Related: Researchers find dozens of venom peptides in blood plasma and fecal samples from COVID-19 patients, CONFIRMING link between toxins and COVID.)

Multiple teams of researchers from around the world followed up on the connection between the coronavirus and the venom of snakes, which led to researchers finding genetic material from at least two

different snake species – the Chinese krait and the Chinese cobra – as well as genetic material from other sources, including from the rabies virus.

Ardis noted in his interview with Ruby that there are certain companies that sell krait venom.

“The exact component of krait venom found in COVID-19 patients,” he said. “You can order it online, and then it designates on the website – you at home get to choose – what do you want your synthetic snake venom from the krait snake to be made in? Do you want it made with yeast, or E. coli or mammal cells?”



Italian study proves Ardis wrong – material from dozens more animals used in virus

But another study, this time from Italy, proved Ardis wrong. As he noted, this study tested blood, urine and fecal samples of people from multiple cities in Italy who tested positive for COVID-19 using PCR testing. The researchers also took blood, urine and fecal samples from people whose PCR tested negative for the coronavirus. These samples were then tested using a variety of lab techniques, including liquid chromatography and mass spectrometry. What the researchers found in those who PCR tested positive for COVID-19 shocked even Ardis.

“They wanted to see if it is true, like the Chinese researchers and French researchers [found]. Is it true that there might be venom peptides causing COVID symptoms?” said Ardis.

“When they ran the sequences of venoms found in the COVID-19 patients only, they actually published 36 different venom sources,” continued Ardis.

He also pointed out that the researchers found material from at least 20 different snake species from the blood and feces samples of the COVID-19 patients. There were also venom samples from at least 16 different marine shellfish species found in the blood and feces samples.

“They also published, they actually found zero animal venoms inside of the negative PCR patients, who did not test positive for COVID,” said Ardis.

"Undeniable smoking gun proof," he added.

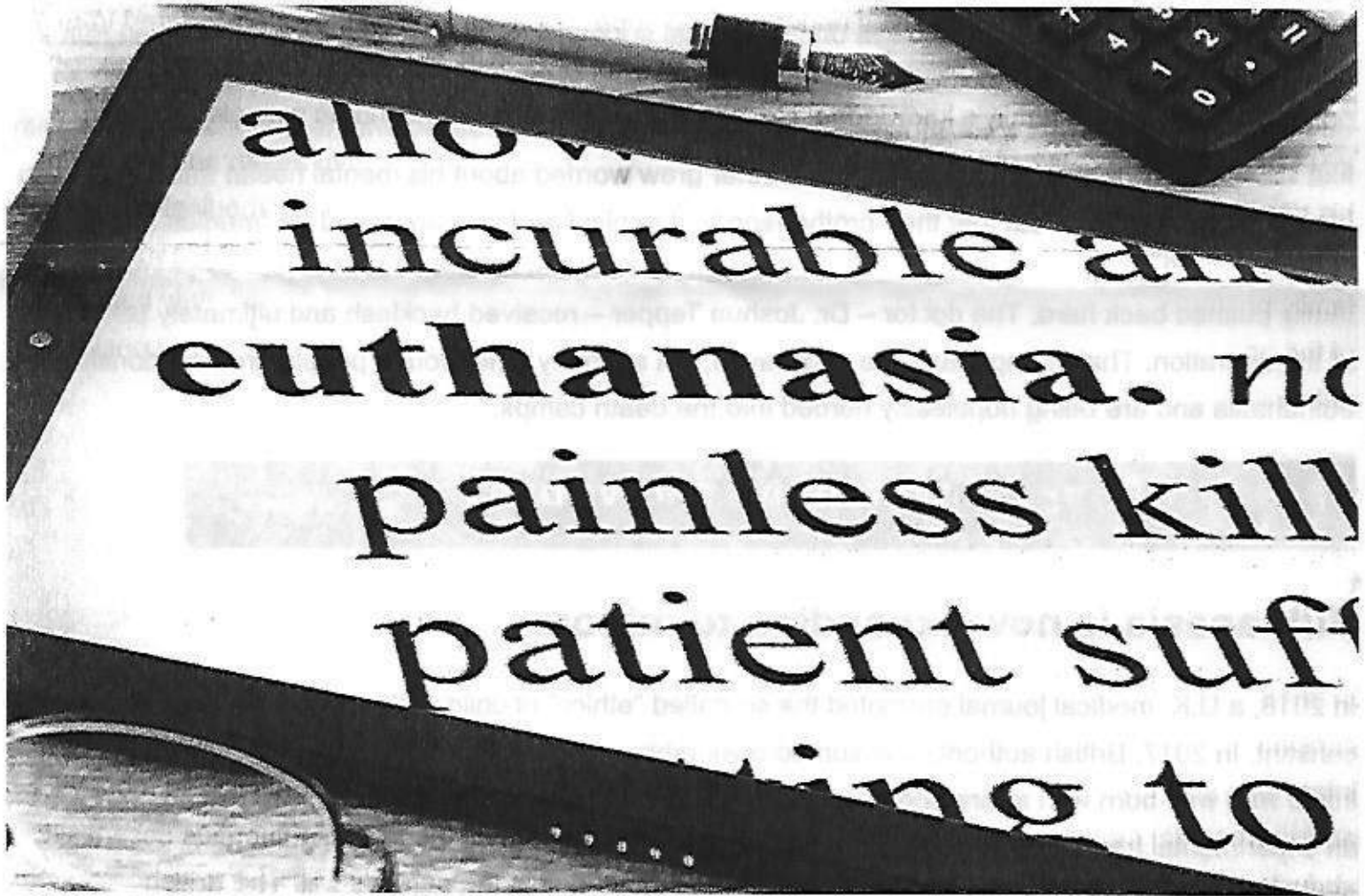

Canada is pro-death: The “world leader in euthanasia” is now considering medically-assisted suicide of children WITHOUT parental consent

(Natural News) In 2021, Canada became the “world leader in euthanasia” – medically-assisting more than 10,000 people to an early death. Since 2016, Canadian medical authorities followed through with 31,000 euthanasia requests. Hospitals there have quickly become death camps, a macabre place where treatment and counseling is withheld, where hopelessness and suicide is encouraged.

As the depravity spreads, the Canadian Parliament is now considering a law that would allow medical authorities to assist minors into a medically-assisted suicide, without parental consent. If this sounds outlandish, here's how far Canada has gone in just a few short years...

The depraved expansion of medically-assisted suicide in Canada, UK

Euthanasia was once a criminal act when carried out on adults. In 2015, the Canadian Supreme Court overturned these criminal prohibitions for assisted-suicide in *Carter v. Canada*. After this infamous ruling, the Canadian Parliament went on to legalize "medical aid in dying" for adults under Bill C-14. This law, passed in 2016, authorized medical authorities to terminate a person's life if their condition was determined to include "enduring and intolerable suffering" or a "reasonably foreseeable death."

By 2021, the Canadian Parliament passed a more cavalier euthanasia law (Bill C-7), allowing people with mental illnesses to kill themselves under medical supervision, as long as they also suffered from a non-mental illness related condition. This paved the way for a 23-year-old, Kiano Vafaeian to seek euthanasia without his family's knowledge. He was chronically depressed and he was also diabetic, with lost vision in one eye. When his sister and mother grew worried about his mental health and logged into his account, they found out that their brother/son had applied and was approved for "medical assistance in dying." A doctor was scheduled to assist Kiano in carrying out his death wish at just 23-years-old. The family pushed back hard. The doctor – Dr. Joshua Tepper – received backlash and ultimately backed out of the operation. That young man's life was saved, yet so many other young people are now considering euthanasia and are being hopelessly herded into the death camps.



Euthanasia is now expanding to minors

In 2018, a U.K. medical journal promoted the so-called "ethics" of child euthanasia without parental consent. In 2017, British authorities assumed ownership over an infant named Charlie Gard, a healthy infant who was born with a rare and severe genetic disorder. Even though the parents raised money for an experimental treatment overseas, and a doctor was willing to help, the British authorities essentially abducted little Charlie from his parents and held the infant against the parent's will. The British authorities sought to terminate the boy's life, claiming little Charlie should "die with dignity." The European courts ruled that Charlie should be removed from life support, and denied treatment. He died at 11 months.

This case has influenced a Canadian parliamentary committee to decide whether to pass a new law that enables Canadian authorities to abduct children and kill them "ethically" without any input from the parents.

In the C-7 law, lawmakers created a provision that opens the door for minors to be euthanized. C-7 calls for a "comprehensive review of the provisions of the Criminal Code relating to medical assistance in dying and their application, including but not limited to issues relating to MATURE MINORS...."
